2. Programme Aims & Overview

Aims

Equip graduates to understand, question and transform how human rights operate in theory, law and practice across diverse global contexts.

Develop advanced knowledge of international and domestic human rights law alongside critical, sociological and decolonial perspectives on social justice.

Build professional capabilities through practice-led learning (clinics/placements), applied research, and writing for policy, litigation and advocacy.

Overview

Human Rights and Social Justice is an interdisciplinary Master's programme rooted in Goldsmiths' strengths in critical theory and practice-based approaches to social change. Bringing together legal, sociological and critical perspectives, the programme equips you to understand, question and transform how human rights work in theory, in practice and in everyday struggles for justice. It offers two pathways, MA and LLM, enabling you to specialise either in sociological approaches to human rights or in legal study. Both pathways engage with international and domestic legal frameworks and the lived realities of inequality, state violence, displacement, climate breakdown and resistance. Core modules in theory and research methods are shared

across pathways, and a range of options allows you to tailor the degree for careers in human rights law and policy, advocacy, research, activism or doctoral study. A distinctive feature is its practice-led ethos through clinics and/or supervised placements with NGOs and community partners, supported by skills workshops on research-to-practice, professional ethics and impact.

7. Programme Structure

For Undergraduate programmes (UG), each level must amount to at least **120 CATS** (60 ECTS).

Postgraduate (PGT) programmes must amount to at least 180 CATS (90ECTS), with exception to interim exit awards.

Programmes are staged in **Phases**, where each Phase relates to an exit award.

Compulsory modules must be taken by all students.

Option modules – you must choose one or more of the options available to this programme at this level and point. The option modules available from this list may vary from year to year, depending on student numbers and staff availability. Selection takes place during your studies, not before.

Programme structure notes (where relevant):

The programme is offered across two pathways, MA and LLM, both of which share a common interdisciplinary foundation and a practice-based learning approach.

Compulsory modules: All MA/LLM students take two core modules: Constructing Human Rights and Researching Human Rights. These modules develop theoretical, critical and methodological foundations across legal and sociological approaches to human rights and social justice.

Pathway Differentiation:

The MA pathway students can choose two option modules from a range of optional modules on sociological, political and cultural approaches to human rights and social justice, including Decolonising Politics: Actions and Ideas from the Global South; Critical and Cultural Analysis; Global Capitalism: Theory and History, and Borders and Migration.

The LLM pathway students can choose two optional modules from legally oriented modules including Gender, Sexualities, and the Law; International Human Rights: Advanced Themes and Contemporary Debates; and Art Law.

Practice-based learning: All MA/LLM students have the option of Human Rights in Practice: Clinic and Placement, a supervised practice-based module in which students gain professional experience with NGOs, grassroots organisations or community partners.

Dissertation: All MA/LLM students complete a dissertation in the summer term, supervised by academic staff in relevant departments according to pathway and research focus.

Full-time students complete the programme over one academic year. In the Autumn Term they take Constructing Human Rights and one optional module, and in the Spring Term they take Researching Human Rights and one optional module. The dissertation is undertaken across the Spring and Summer Terms.

Part-time students complete the programme over two years. In Year 1 they take Constructing Human Rights in the Autumn Term and Researching Human Rights in the Spring Term. In Year 2 they take two optional modules, one in each term. The dissertation is undertaken across the Spring and Summer Terms in Year 2.

8. Learning, Teaching & Assessment

Learning & Teaching methods

Teaching will be via a range of formats to be as relevant as possible to the topic and learning outcomes. This may be through workshops, practical labs, lectures and seminars. It may have a mix of in-person and online activities, designed to give you the best learning experience and to make the

most out of your learning experience. You are expected to attend all of your timetabled learning activities.

Specifically, this programme will be taught in the following ways:

Teaching combines lectures, seminars, workshops, skills labs, and supervised practice-based learning (clinic/placement), with an emphasis on research-informed, practice-led and critically engaged pedagogy. The programme is taught by academic staff with extensive research and professional experience in human rights and social justice. Guest speakers from NGOs, legal practice and advocacy contribute across both pathways where appropriate.

Specifically, this programme will be taught in the following ways:

Lectures and research-led seminars: providing theoretical, legal and critical grounding in human rights and social justice across both pathways

Workshops and skills labs: covering research methods, translation of theory and research into practice, and professional writing skills (including writing for policy and litigation)

Supervised practice-based learning: via clinic and placement module, in which students work with NGOs, community organisations or legal practitioners and develop applied professional skills alongside their academic study

Dissertation supervision: combining individual one-to-one supervision with group research support sessions in the summer term.

Assessment modes and approaches

You will be assessed in a range ways throughout your course. These will be both Formative (for feedback and development), and Summative (required to pass and progress to the next level). Summative assessments are compulsory.

Feedback is a crucial part of your learning and development in this programme. You will receive feedback both on your Formative (work in progress) tasks/assessments, and your Summative (graded) assessments. This feedback will help the assessment to be a part of your learning, not just a test. It may be verbal, written or video based. Please engage with this feedback to improve your future work.

Specifically, this programme will be assessed in the following ways:

Assessment balances academic and practice-oriented outputs, including essays, research proposals, portfolios, reflective journals, policy briefs, case analyses, presentations and a dissertation. The clinic/placement is assessed via an evidence-based practice output and reflective portfolio
