## Reports and disclosures of Sexual Harassment, Sexual Violence, Sexual Misconduct, Domestic Violence and Stalking received in academic year 2017-2018.

This document relates to reports and disclosures of sexual harassment, sexual violence, sexual misconduct, domestic violence and stalking received by Goldsmiths, University of London via the College's Report and Support online reporting tool in academic year 2017-2018.

This tool enables anyone connected to Goldsmiths to report or disclose such behaviours, anonymously if preferred.

It is the first such iteration of these figures, which will now be published on an annual basis.

Full definitions of what constitutes a report or a disclosure, and an explanation of how the College can respond to a report or a disclosure, can be found in the College's <u>Policy on Sexual Violence</u>, <u>Sexual Harassment and Sexual Misconduct</u>.
